THE MINUTES OF ANNUAL GENERAL MEETING OF THE FINANCIAL YEAR OF 2023 – THE FIRST CALL – OF DC DYNAMIC SECURITIES FUND (DCDS)

I- FUND INFORMATION:

II- AGM'S TIME AND VENUE:

The annual general meeting of the financial year of 2023 of DC DYNAMIC SECURITIES FUND (DCDS) was inaugurated at 9.00 AM on April 10th, 2024 at 1st floor, Renaissan Riverside Saigon Hotel, address no 8-15 Ton Duc Thang Street, Ben Nghe Ward, District 1, Ho Chi Minh City, Vietnam.

III- QUORUM AND LEGITIMACY OF THE AGM:

Recorded at 10.30 AM on April 10th,2024, the number of investors attended (in persons or via proxy or voting notes delivered) at the AGM were: 35 investors representing for 53,923.36 fund Certificates, accounts for 0.23% total voting fund Certificates.

The AGM recorded the confirmation report of investors attended as follows:

- Total voting notes: 23,210,044.15 Fund certificates
- Total voting notes invited to attend: 27,393 investors representing for 23,210,044.15 voting fund certificates.
- Number of attendants (in person or via proxy or voting notes delivered): 35 investors representing for 53,923.36 fund Certificates, accounts for 0.23% total voting fund Certificates.

Accordingly:

- Pursuant to Clause 1 Article 24 of the Charter of DC DYNAMIC SECURITIES FUND (DCDS), The AGM of the financial year of 2023 of DC DYNAMIC SECURITIES FUND (DCDS) – the first call on April 10th, 2024 – is not qualified to conduct due to the attended voting fund certificates of investors lower than 50% the total

voting fund certificates based on the list of investors entitled to attend that was finalized on March 11th, 2024.

- Pursuant to Clause 2 Article 24 of the Charter of DC DYNAMIC SECURITIES FUND (DCDS), the second call of AGM of the financial year of 2023 will be conducted within thirty (30) days since April 10th, 2024 with the attendants that was listed on March 11th 2024. Form of the meeting shall be in person. Means of attendance: The investors attend in person at AGM, or via proxy or delivering the voting notes to the address of DCVFM as regulated.
